WHEREAS the Hyde Park Trail system enhances the public's opportunity to appreciate and support the preservation of the historic, scenic, cultural, recreational and natural resources of the Hudson River Valley, and provides health benefits to community residents, and

WHEREAS, the original 3.6-mile section of the Hyde Park Trail was the first trail in the Hudson River Valley to be designated as Hudson River Greenway Trail in 1991, and has served as a model for many other communities since that time, and

WHEREAS, the Town of Hyde Park believes the entire, approximately 30 miles of the Hyde Park Trail system qualify for designation as riverside trails and connector trails as part of the Hudson River Greenway Trail System,
