RESOLUTION 1:1 - 1 OF 2020

RESOLUTION AUTHORIZING THE TOWN OF HYDE PARK TOWN BOARD TO APPOINT JOANNE LOWN AS COMPTROLLER FOR THE TOWN OF HYDE PARK

WHEREAS, the Town Board, by Resolution 6:16-4 of 2010, created the position of Town Comptroller; and

WHEREAS, this position was vacated by the retirement of former Hyde Park Town Comptroller Thomas Carey, effective December 31, 2019; and

WHEREAS, the Town Board wishes to appoint Joanne Lown to fill said vacant position effective January 1, 2020.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Hyde Park does hereby appoint Joanne Lown as Comptroller for the Town of Hyde Park in the exempt jurisdictional class effective January 1, 2020, with all the powers and duties as set forth in Sections 34 and 124 of the New York Town Law; and

BE IT FURTHER RESOLVED, that Joanne Lown shall hold the office of Comptroller, at the pleasure of the Town Board from January 1, 2020 through December 31, 2021; and

BE IT FURTHER RESOLVED, that the annual salary of the Town Comptroller shall be set at \$65,000.00; and

BE IT FURTHER RESOLVED , that said appointment is subject to all statutes, rules, regulations and guidelines of the Civil Service law of the State of New York and the Dutchess County Department of Human Resources; and

BE IT FURTHER RESOLVED , that this appointment is subject to, and conditioned upon, the execution of an Employment Agreement between the Town of Hyde Park and Joanne Lown to be approved by the Town Supervisor and the Attorney to the Town; and

BE IT FURTHER RESOLVED , that the Town Board of the Town of Hyde Park does also hereby authorize the Town Supervisor to execute said Employment Agreement upon its approval; and

BE IT FURTHER RESOLVED , that the Town of Hyde Park Town Board wishes to extend their sincere gratitude to former Town of Hyde Park Comptroller Thomas Carey for his many years of dedicated service to the Town of Hyde Park.


