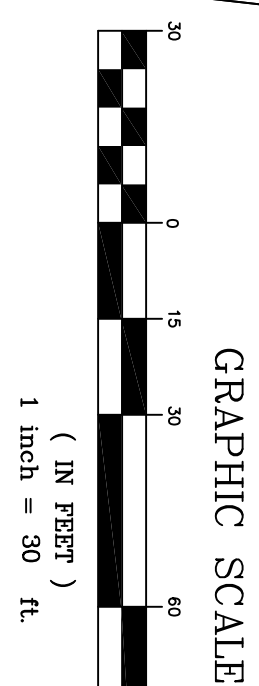




1 SITE PLAN - PROPOSED SITE PLAN
